**SAFETY PROCEDURES**

- A responsible adult must supervise the unit at all times.
- Under no circumstances must the equipment be interfered with or moved.
- In the event of high winds or inclement weather deflate the inflatable immediately.
- Never overcrowd a unit and segregate different aged children.
- Ensure that no persons are on, or in the inflatable while inflating or deflating and never remove the plug without first checking.
- Person using the inflatables must remove footwear, Belts, Glasses, and Jewellery.
- No toys, sharp objects, food, or drink allowed on the unit.
- The hirer is responsible to cover any hard surfaces adjacent to the entrance / exit with mat or soft materials.
- No adults or pets are permitted to use our inflatables.
- No children are ever permitted to climb on the walls of the inflatable.
- On inflatables with slides, children must go down feet first.
- Any damage or loss must be reported immediately.

**RENTAL CONDITIONS**

- The hirer will pay monies due upon installation.
- The hirer is responsible for the inflatable whilst in your care.
- Cleaning costs will be charged if the unit is returned in unacceptable condition.
- Any malicious damage or loss is the hirers responsibility.
- Once the equipment is installed it must not be moved, have items added to, be altered in any way or used for any purpose other than which it has being designed for, without written permission from Big Bounce Castles & Marquee Hire Ltd.
- The proposed operating site for the inflatables is clear of any obstacles that may prove to be a hazard for the safe operation of the inflatables and clear of any underground services. ( Gas, Water, Electricity). Big Bounce Castles and Marquee Hire Ltd. cannot be held responsible for any damage caused to underground services by erection of any supplied inflatables.
- Only children between the ages of 3 and 12 shall be permitted to use the inflatable. In addition, no child whose height exceeds the height of the walls of the inflatable shall use the inflatable.
